A local law to amend the Hammond Site Plan and Subdivision Review Law

Be it enacted by the Town Board of the Town of Hammond as follows:

The Town of Hammond Site Plan and Subdivision Review Law is hereby amended by adding a Section 2.8 thereto to read as follows:

Section 2.8. Wind Energy Facilities

Notwithstanding anything to the contrary contained in this Article II, Wind Energy Facilities as that term is defined by Town of Hammond Local Law No. 1 of the Year 2009, entitled Wind Energy Facilities, that are governed by the provisions of Local Law No. 1 of the Year 2009, shall not be subject to site plan review under this Local Law.




