EXECUTIVE SESSION

- **1. Motion** by Supervisor Bertram to enter executive session for litigation at 6:45pm and second by Councilmember Tague. The motion carried 5 ayes.
- **2. Motion** by Councilmember Delosh to leave executive session at 7:05pm and second by Councilmember Tague. The motion carried 5 ayes.

OLD BUSINESS

- 1. **REDI**: The Board agreed that a wider ramp is better than two ramps and will ask Fourth Coast to redo the Chippewa Bay dock plan using the concepts of the Chippewa Bay Launch Committee's drawing but, from the drawing, shorten dock B and A and widen space between docks C and D.
- 2. The Chippewa survey is on Rob Busler's desk.
- 3. The Yacht Club has requested a formal parking study in Chippewa Bay.

 Motion by Councilmember Tague to ask the County for a formal parking regulation study in Chippewa Bay. Second by Councilmember Delosh. The motion carried 5 ayes.
 - **a.** Councilmember Delosh said parking enforcement is important.
- **4. Motion** by Councilmember Delosh for a public hearing on October 13, 2021 at 7pm for the new Land Use Law. Second by Councilmember Pitcher. The motion carried 5 ayes.

NEW BUSINESS

- Marcia Thompson-Amyot, representing the Hammond Free Library, asked the Town Board for an opinion on a library sign to post on the new office building. The Town Board agreed on a 12"/42" sign hung from the eaves on the library side of building.
- **2. Motion** by Councilmember Elk to pay \$1008.83 for a dedication plaque to go in new building in honor of Mr. and Mrs. Ceresoli Sr. Second by Councilmember Delosh. The motion carried 5 ayes.
